KITCHEN ANGEL CRAFT

Materials Needed: 1 hand towel

1 matching dish cloth1 matching hot pad

24" narrow ribbon (30" is easier)

Directions:

Cut off all labels. Lay towel flat on work surface. Fold like an accordion making sure that both edges face the same direction. Then fold in half. Take 15" of the ribbon and tie it around the towel 2" below the rounded fold. Have excess ribbon going the same direction as the edges. Gather the hot pad into pleats with the loop on top . Tie it with the same ribbon as tightly as you can putting the ribbon through the loop.



Take the dishcloth and lay it flat on your surface. Bring opposite corners into the center. (Watch the design on the cloth as you may want to offset the corners so the design shows better.) Then fold in thirds, tuck under the hot pad as far up as you can get it. Bring cloth around the towel overlap the ends, and tie securely with ribbon. Add flowers and make a small bow with excess ribbon.

COMMUNITY SERVICE PROJECT

Wheelchair Bag

Cut:

Bag - 2 pieces 14" x 16" Outside pockets - 1 piece 14" x 14" (contrasting material) Straps - 2 pieces 3" x 11"

Sew:

Outside pocket fold in half, right side in and sew as a sleeve. Turn right side out. Press. Top stitch one long side. Place this piece on right side of 14" x 16" halfway down so that 14" ends match. Stitch outside pocket bottom to bag halfway down. Stitch outside pocket into 3 pockets at about $3 \frac{1}{2}$ " - $5 \frac{1}{2}$ " - 4" or any other size.

Place right sides of each 14" x 16" together and make 2 bags 8" x 14". Stitch side seams for each bag. Turn one bag with outside pocket to right side out. Insert other bag inside first. Fold top raw edge under 1/4" on both. Pin tops of 2 bags together.

Take strap material. Right sides together the long way. Turn right side out. Insert one end of each tube into top of bag about 3" from outside edge.

Top stitch the top of 2 bags together with strap in. Attach Velcro on other end of straps.

Press seams as you go.

CHRISTMAS GATHERING - DEC 11, 2024


Everyone is invited to our Christmas event slated for Wednesday,

The following is a list of 125 items that often need to be considered following the death of a loved one. Many of the items on this list can be collected or planned in advance, helping to remove a significant burden from loved ones during a most challenging time.
